
Limited Registration Puppy Contract

Terms and Conditions

1. The Breeder and Buyer agree as follows:



- **1.2. Purchase Price.** The full purchase price of \$_____ ("Purchase Price") is agreed with the balance due in full (a) at least _____ days before the puppy/dog is delivered to Buyer or (b) upon Buyer's pickup of the puppy/dog. Any shipping and handling expenses are the responsibility of and shall be paid by Buyer. All payments due under this Agreement shall be made in US Dollars,
- **1.3. Limited Registration.** The puppy/dog is a [AKC_____] and is being sold with limited [AKC] registration. [Breeder agrees to provide Buyer with all [AKC] registration papers.] As such, the puppy/dog is not eligible for exhibiting in Conformation (but may compete in other performance events, such as Agility, Obedience, and Rally). The puppy/dog shall not be bred at any time and if pups are produced, such offspring will not be eligible for [AKC] registration.
- **1.4. Unauthorized Breeding.** The puppy/dog is being sold solely as a companion and breeding of the puppy/dog is expressly prohibited. **Buyer** agrees to have the puppy/ dog spayed / neutered by 18months of age.

2. Breeder's Obligations. Breeder represents and warrants the following:

- **2.1.** Ownership. Breeder is the lawful owner of the puppy/dog and has the right to transfer ownership of the puppy/dog to Buyer. Ownership of the puppy/dog will be transferred to Buyer [upon Buyer's payment of the full Purchase Price]
- **2.2.** The puppy/dog was previously examined by a licensed veterinarian and was found to be in good health at that time and has had the immunizations enumerated in the health records provided to Buyer. The puppy is not exhibiting any signs of sickness at time of pick-up such as, vomiting, lethargy, fever or coughing / sneezing. The puppy is bright alert and exhibiting normal behavior.
- **2.3.** Your puppy is guaranteed until two years of age against fatal and life altering congenital diseases. This includes hip dysphasia, which hampers a dog's movement and requires surgery to correct. Heart and liver problems of a severe life threatening or altering nature are included. In the unlikely event that this occurs, I must be notified within 48 hours of the licensed veterinarians determination, by phone. At buyers' expense, I will need to be sent report from licensed veterinarian stating the heath concern/diagnoses.
- **2.4.** This Guarantee does NOT cover Cherry eye, Entropion, Ectropion, Allergies, undescended testicles, loose knees or hips, hernias, dermatitis, demodetic mange. Seller will NOT replace a puppy due to heat stroke, abuse/neglect, or improper socialization. During shipping, puppies can become stressed by the change in environment. Minor problems such as diarrhea, coccidiosis, upper respiratory, kennel cough etc. These are the responsibility of the buyer not covered under the health guarantee, any condition that is non genetic and can be cured with medication will not be covered by this guarantee.
- **2.5.** If it is determined by a licensed veterinarian that the puppy/dog (i) was "unfit for purchase" or (ii) has a genetic disorder that is identified within the warranty periods described above, the Buyer may return the puppy, for a future puppy from another litter.

3. Buyer's Obligations. Buyer agrees to the following:

- **3.1.** <u>Proper Care.</u> Buyer will provide good and proper care of the puppy/dog. Such care includes providing adequate housing and protection from the elements, a safe (preferably fenced) exercise area, and proper and sufficient nutrition. Buyer will provide proper veterinary care throughout the puppy/dog's lifetime, including but not limited to, routine vaccinations and/or titers to maintain the puppy/dog's immunity to common canine diseases.
- **3.2.** <u>Veterinary Care</u>. Buyer will also provide the following veterinary care: (i) routine vaccinations and/or titers to prevent common infectious diseases; (ii) routine treatment for internal and external parasites; and (iii) annual examination by a licensed veterinarian.
- **3.3.** Restrictions on Transfer. If, at any time, Buyer is unable to keep or care for the puppy/dog (including upon Buyer's death or incapacity), at Breeder's sole election, the puppy shall be (a) returned to Breeder together with duly executed documentation transferring Buyer's ownership interest in the puppy/dog to Breeder or (b) rehomed by Buyer with Breeder's prior written approval.
